Reararticulating Our Mission

The Bar Foundation Board is conducting a strategic thinking process with the goal of becoming a more proactive service arm of the SC Bar. In this process, the Board reflected upon the mission of the Foundation which was stated as, "To fund and support legal representation for low income citizens; provide law related education services to the public; improve the administration of justice and enhance the legal profession for members of the bench and bar of South Carolina."

That mission continues to define who we are, who we fund and what we do. We will now rephrase that mission to read as follows: "**Our mission is to fund the advancement of justice by improving access, education and accountability.**"

Honor a Distinguished Member of the Bar

The Bar Foundation currently is accepting nominations for the 2008 DuRant Distinguished Public Service Award. Recipients are nominated and selected by their professional peers, establishing this recognition as one of the most prestigious statewide awards that members of the Bar can bestow on a fellow attorney.

Selection criteria include meritorious service to the law and the community. Eligibility is limited to living members of the South Carolina Bar. Sitting judges and current public office holders are not eligible; however, past service in such positions will be considered. The award recipient will be honored at the Bar Convention's plenary luncheon in January 2009.

Foundation Helping Organizations Attract and Retain Legal Staff

The Bar Foundation announces awards totaling \$170,978 to 32 civil legal aid attorneys for loan repayment. This is the second year of awards through the Ness-Blatt Loan Repayment Assistance Program (LRAP) pushing the total upwards of \$330,000.

LRAP assistance is considered a forgivable loan. To have the loan forgiven, a participant shall complete a year of employment with a qualifying employer and make educational debt payments (interest and/or principal) that equal at least the amount of Foundation and other LRAP assistance received during the award year. By forgiving loan awards in exchange for service at the organization, the Foundation is hopeful that more hard-working and dedicated legal services lawyers will be able to remain in the legal services arena.
